Subject: FMC Corporation Lithium Business rebranded as Livent Corporation

Dear Valued Supplier:

As we previously announced publicly, FMC Corporation (“**FMC**”) intends to enter into a series of transactions to separate its lithium business and related assets and to conduct an initial public offering of the business. We are very excited to announce that the holding company of the lithium business will be rebranded as **Livent Corporation** (pronounced **lye-vent**) (“**Livent**”), and as of October 1, 2018, Livent will be the owner, directly or through one or more of its subsidiaries, of all the assets and liabilities of the lithium business.

In connection with the separation of the lithium business, there will be changes to the legal entities that handle procurement for Livent. Effective October 1, 2018, FMC will transfer your commercial relationship with FMC to FMC Lithium USA Corp., which will be a wholly owned subsidiary of Livent. This letter shall serve as notice to you of this assignment.

We will continue to process invoices under the FMC Corporation name until all open purchase orders are fulfilled. As of October 1, all new purchase orders will be issued under the name FMC Lithium USA Corp. The invoicing address for these POs will remain the same. For your reference, however, we are attaching a list of our locations, legal entity names and invoicing addresses.

Following our separation into a publicly traded company, you will begin to see our Livent brand reflected on invoices, packaging and other materials. We are committed to communicating any changes clearly and ensuring you experience no interruptions or delays.
